- I. President Myra Adkins called the meeting to order at 6:20 pm. Meeting held via Zoom.
- II. General meeting minutes from **April 12, 2021**: Approved as presented.
- III. **President's Report** – Myra Adkins - Welcome back, discussed Trojan Transition Camp, Campus Clean up, and the first day of school.
- IV. **Student Body President** – Carter Hull – Discussed the parking lot flow at school dismissal, Homecoming is tentatively scheduled for September 25th, but could change with COVID guidelines, Prom is scheduled for April 2nd at the UT Alumni Center.
- V. **Principal's Report** – Sammi Harrison – AHS prepares for a student body of 2200 to have a 28 to 1 teacher student ratio, on August 17th there were 2330 students enrolled. As of August 23rd, 2200 students are enrolled, 330 students either were no shows, relocated/moved or transferred. There are 15 students quarantining due to COVID or being exposed to someone with COVID. Discussed traffic flow at dismissal with students and buses trying to depart the student parking lot. AHS is going to a nine week grading period. Back to school night is scheduled for September 9th at 6 pm and 7 pm and will be virtual and in person. No positive COVID tests for AHS staff. Remind app is an app that will alert students and parents of shelter in place notice and fire drills. Taco Shack Bowl is Thursday, August 26th at 7:30 pm. AISD is allowing 100% capacity at House Park. Discussed campus beautification and future plans.

Treasurer, Holly Munin – The treasurers report today covers the year through July 2021. Our beginning balance as of July 1, 2021 was \$112,880.34. Total income for July was \$4,055.42 with \$146.23 in expenses yielding an ending balance of \$116,713.03 as of July 31, 2021 (cash flows tab). We began August with that balance.

Budget 2021-2022: Review budget to actuals report and explain the Exec Cmte is discussing fundraising or adjustment options to address deficit.

Annual Reconciliation for YE June 30, 2021 occurred on July 7, 2021 and the report will be presented at the next General Meeting.

The YE June 30, 2021 990 Tax Return has been completed. It was presented to the Executive Committee on the 18th, approved, it has been signed and will be filed by August 31, 2021 as required.
